Wabigoon Lake is located in North Western Ontario and is a party to Treaty #3. We sit approximately 2km away from the existing natural gas pipeline and if the proposed project gets approved we will be directly affected. Wabigoon Lake Ojibway Nation's traditional territory stretches Through Vermillion Bay, ON to English River, ON, the Pipeline is directly along this route. Wabigoon Lake Ojibway Nation exercises Aboriginal and Treaty rights in the area of the proposed project.

If allowed to proceed, the proposed Project will negatively impact Wabigoon Lake Ojibway Nation's ability to exercise their Aboriginal and Treaty rights. The land and water along the route is traditionally used and occupied by our families, and the water in question serves as our community's source of drinking water. The safety of the land and water affected is essential to our community's well being.

Wabigoon Lake holds traditional knowledge in respect of the project which may be relevant in the NEB's assessment as to whether the project should proceed.

The EEP has the capacity to greatly impact Wabigoon's natural resources and ecosystems in the event of an malfunction or spill. Wabigoon Lake has a flourishing amount of Manomin (Wild rice) and is traditionally harvested by community members each season, a right that is protected by treaty. Wabigoon Lake Ojibway Nation takes pride in preserving our Manomin and other natural resources for future generations. If an oil spill were to occur we would potentially lose our Manomin and other natural resources permanently, and lose any meaningful ability to exercise our constitutionally protected treaty rights.

The Crown has a constitutional duty to consult with Wabigoon Lake Ojibway Nation regarding the Energy East Pipeline Project. The proposed Project is also subject to Manito Aki Inakonigaawin (The Great Earth Law)

Wabigoon Lake Ojibway Nation is concerned about the potential impacts associated with this Project, including potential destruction of terrestrial and aquatic ecosystems including fisheries, the destruction of plants and medical plants, the disruption of sacred grounds, burial grounds and traditional sites, and the erosion of lands from the First Nation's traditional territory.

Wabigoon Lake Ojibway Nation is a member of, and supports, Grand Council Treaty 3. However, as Wabigoon Lake Ojibway Nation is an independent self – governing First Nation, Wabigoon Lake Ojibway Nation is applying to participate as an intervenor before the NEB independent of Grand Council Treaty 3.
