1. Appropriateness of proposed North Bay Junction Long Term Fixed Price (LTFP) service
2. Appropriateness of the proposed tolling methodology for the service, the North Bay Junction LTFP Contract and Toll Schedule and consequential amendments to the Canadian Mainline Gas Transportation Tariff.

Enbridge Gas New Brunswick Limited Partnership ("EGNB") was awarded capacity to use this service beginning November 1, 2021. EGNB is a current shipper of long haul capacity from Empress to East Hereford on TCPL and considers access to the Western Canadian Sedimentary Basin ("WCSB") critical in meeting the natural gas supply need of its franchise in New Brunswick. EGNB does not have access to local supply, nor local natural gas storage facilities to meet its franchise needs at this time and considers the WCSB as a valuable asset in meeting the needs of Atlantic Canada long term. EGNB also participated in another recent expansion project (Portland XPress) to add diversified supply from Dawn, ON to EGNB's supply portfolio. Overall landed cost of supply is of critical importance to EGNB, as the New England/Atlantic Canadian natural gas market is both the highest overall price and the most volatile in North America on an annual basis. By having access to long term supply with generally low volatility, EGNB is better able to provide valued service to our franchise area and provide an economical energy source which helps reduce the carbon footprint of this region in Canada. TransCanada's North Bay Junction Long Term Fixed Price Service provides an opportunity for EGNB to reduce energy costs and achieve growth in its franchise market.
