<p>The Industrial Gas Users Association (“IGUA”) is a stakeholder that represents industrial consumers in Ontario and Quebec, who, ultimately, bear the cost consequences of TransCanada PipeLines Tolls on their invoices, either directly as a shipper or indirectly via their Distribution company. IGUA will be sufficiently impacted by the National Energy Board’s decision with respect to this application.</p> <p>IGUA supports the proposed North Bay Junction Long Term Fixed Price Service as it secures gas flow on the Mainline at competitive tolls, providing a market responsive offer. IGUA is also supportive of the proposed Streamlined Process to facilitate early implementation of the service.</p> <p>IGUA does not intend to be active in the proceeding.
