Trans Mountain Pipeline ULC (Trans Mountain) Trans Mountain Expansion Project (Project) Summary Letter of Project Filings and Commission of the Canada Energy **Regulator Decisions and Correspondence – March 2024**

On 28 August 2019, the Canadian Energy Regulator Act (CER Act) came into force and as a consequence the National Energy Board (**NEB**) is now the Canada Energy Regulator (**CER**). Every decision or order made by the NEB is considered to have been made under the CER Act and may be enforced as such. Every certificate, licence or permit issued by the NEB is considered to have been issued under the CER Act.

In order to provide better understanding and transparency on company filings and the decisions and correspondence on the Project made by the Commission of the CER, the CER will continue to provide a regular summary of Project condition filings and non-routing variance filings and submissions, as well as Commission correspondence.

Filings submitted in compliance with Certificate OC-065 and associated Amending Orders will be on the public record within the CER's regulatory documents repository, specifically in the Certificate and Compliance (MH-052-2018) folder.

The CER has refined a series of tables that are attached as Appendix 1. Table 1 provides details on condition compliance filings, including links to filings received in the previous month. Table 2 provides a list of the non-routing processes that are in progress, and any applications and filings received since the issuance of the last letter. Table 3 provides a list of Project filings related to the CER Leave to Open applications that are in progress, which are required before facilities can go into operation. Table 4 provides a list of the Project filings that the CER expects to receive this month.



Canada

The CER's <u>Project webpage</u> will be kept up-to-date and its regulatory documents repository <u>REGDOCS</u> contains the complete record of information on the Project. In addition, a complete list of past NEB and CER Summary Letters is provided in Appendix 2. The CER's online webtool – <u>The Project Conditions Table</u> – allows the Indigenous Advisory and Monitoring Committee – Trans Mountain (**Committee**), Trans Mountain, and the public to explore the Project's conditions by theme and lifecycle stage. It shows condition filings from Trans Mountain, the Commission and other parties and shows whether conditions have been satisfied. Trans Mountain and the Committee, as well as any other persons interested in updated information, are encouraged to use to this resource.

The safety of the public, workers and the protection of the environment is of paramount importance. The CER will hold Trans Mountain accountable for its compliance to all CER regulatory requirements and commitments for its existing and approved pipeline system.
