On August 26, 2019,¹ the National Energy Board (NEB), predecessor to the Canada Energy Regulator (Commission), approved the Financial Resources Plan for TQM.

Under the *Pipeline Financial Requirements Guidelines* (Guidelines), companies are required to file an update to their Financial Resources Plans by April 30 each year.²

Pursuant to the Guidelines, TQM filed an update to its Financial Resources Summary on April 26, 2024,³ and indicated that an updated certificate of insurance would be filed with the Commission upon renewal. Enclosed is TQM's updated certificate of insurance along with a letter confirming the insurer's A.M. Best Rating.

In accordance with the Commission's Decision⁴ on TQM's confidentiality request filed on May 25, 2021,⁵ TQM's updated certificate of insurance has been redacted to protect the confidentiality of TQM's insurance provider. An unredacted version of the updated certificate of insurance will be provided in confidence to the Secretary of the Commission.
