The Tribe has stewardship of its traditional territory where its seven member communities hold Aboriginal rights and title: Shxwhá:y (Skway) First Nation; Th'ewá:li (Soowahlie) First Nation; Ch'íyáqtel (Tzeachten) First Nation; Sxwoyehálá (Squiala) First Nation; Sq'ewqeyl (Skowkale) First Nation; Áthelets (Aichelitz) First Nation; and Yeqwyeqwi:ws (Yakweakwioose) First Nation, all of whom appear on the Crown consultation list for the Project. The Project involves the expansion of a pipeline which has potential impacts to the Tribe's traditional territory and its member communities' Aboriginal rights and title.
