Genealogy of Three North Slave Métis Families

Method:

In 1920, H.A. Conroy, the treaty commissioner responsible for Treaty 11 named seven Métis families he described as "old and respected" and "historic". Three of the seven families (Lafferty, Bouvier, and Camsell) are central progenitors to the membership of the North Slave Metis Alliance (NSMA). A genealogy of these three Métis families was partially re-constructed from the claims (scrip applications) filed by members of the families in the Red River in 1875, Treaty 8 (1899), and Treaty 11 (1921). These records were originally created by the federal Department of the Interior and are now accessioned in the National Archives of Canada, RG 15. The records provide evidence of Métis ethnicity and information on genealogy, residence, and employment history. The records are restricted to Métis and their children who filed claims. The scrip claim information is corroborated and supplemented with employment data from the Hudson's Bay Company and Northwest Company employment records, census data, and published sources. The data confirms that the three named families have long historic roots in the North Slave region and were part of an endogamous Métis society that was an interactive satellite of the Red River Métis nation.

Descendants of Joseph Lafferty

Generation No. 1

1. It is not known when JOSEPH LAFFERTY was born or when he entered the fur trade in the Athabasca district. JOSEPH appears in the Northwest Company records in 1814 and in the Hudson's Bay Company (HBC)'s records for Athabasca from 1821 to 1827. At an unknown date, JOSEPH married MARIE GOYETTE. JOSEPH and MARIE's children (PIERRE and LOUIS) are identified as Métis by some of their children, which suggests that JOSEPH or MARIE, or both, were aboriginal.

Generation No. 2

In 1814, PIERRE LAFFERTY began employment as a voyageur with the NWC. In 1819, LOUIS, his younger brother, joined him. By the end of 1819, the two brothers left the NWC and joined the HBC in the Athabasca District. HBC account books indicate that PIERRE and LOUIS worked alongside each other. In 1825, both men were assigned to the Great Slave Lake district. In their first years of work (1814-1821), PIERRE and LOUIS worked alongside other Métis whose names would figure in the lives of their descendants for generations: BOUCHER, BOUVIER, FABIEN, FAILLE, GENEREUX, MANDEVILLE, ST. GERMAIN, and VILLENEUVE.

In 1819, a HBC manager described LOUIS LAFFERTY as, "a grumbling fellow, but a good voyageur". Six years later, he described LOUIS as an "indefatiguable voyageur". In 1832, after 13 years of service, LOUIS left employ with the HBC and the next year, married a Métis, AGATHE CARON (born July 15,

employee who appears in the NWC records for Athabasca in 1819-1821, and was transferred to the HBC in 1821. The ST. GERMAIN family is one of the most researched Métis families in the subarctic. The historian H. W. Duckworth compiled the biography of PAUL ST. GERMAIN. C. Stuart Houston has researched and written the biography of PIERRE ST. GERMAIN, the well-known guide to Sir John Franklin. PIERRE ST. GERMAIN first appears in the NWC employment records in 1816 and was transferred to the HBC in 1821. In 1835, PIERRE ST. GERMAIN bought lot 47 in St. Vital and retired to the Red River settlement. In 1838, at the age of 39, LOUIS LAFFERTY retired to farming in the Red River. LOUIS LAFFERTY bought lot 173 in St. Norbert, next to his wife's family lot (CARRON, Lot 174 ST. Norbert). From 1849 to 1855, LOUIS returned to the fur trade as a steersman between Norway House and Lake Athabasca. The next year he acted briefly as a freeman in the Red River settlement. LOUIS and AGATHE had 7 children. LOUIS children identify him as Métis in their scrip applications.

In 1825, a HBC manager described PIERRE LAFFERTY as a "good middleman. Excellent fisherman, industrious, honest, respectful to his officers, careful of the company's property, and always ready to perform his duty with cheerfulness". PIERRE stayed in the Great Slave Lake fur trade until 1843. By 1826, HBC records show he was married. Indeed, he married a Métis, MARIE ANNE GENEREUX, a relation of one of the three GENEREUX men he worked with. NWC and HBC records indicate that JEAN PIERRE, JOSEPH, and LOUIS PIERRE GENEREUX had long careers in the Athabaska district. In 1843, PIERRE LAFFERTY took up farming in the Red River. From 1860 to 1864, PIERRE acted as a freeman in several districts and died in 1865. LOUISSON identifies his father PIERRE as Métis. MARIE ANNE GENEREUX is consistently identified as Cree in her children's scrip applications.

4. In 1819, a HBC manager described ANTOINE LAFFERTY as "a good voyageur". HBC records register ANTOINE's employment in the Athabasca district from 1819 to 1821. No other records for ANTOINE have been located and his children, if any, are not known.

Generation No. 3

In 1854, OLIVIER LAFFERTY began employment with the HBC at the newly established Fort Rae and continued to work there until 1864. In 1860, LOUISSON joined his brother OLIVIER at Fort Rae and made it his place of work and home until his death around 1900.

5. In 1828, OLIVIER³ (PIERRE², JOSEPH¹) LAFFERTY entered the service of the HBC at Lac la Pluie and in 1831 and 1832 tripped to Montreal for the company. From 1832 to 1853, OLIVIER worked for the HBC in British Columbia. In 1854, OLIVIER LAFFERTY began employment with the HBC at the newly established Fort Rae and continued to work there until 1864.²³ He married a Métis, MADELAINE

FAILLE (born June 12, 1829) daughter of TOUSSAINT FAILLE and ANGELIQUE SANCHEAU. ²⁴ OLIVIER'S father (*PIERRE*²) had worked with MADELAINE'S father, TOUSSAINT, from 1821 to 1832. TOUSSAINT had a long career with the HBC and NWC in the Athabasca district. ²⁵ In 1865, TOUSSAINT appears in the HBC records as a freeman in the Red River settlement where he held land at lot 87 in Ste. Agathe. The children of MADELAINE and OLIVIER describe both parents as Métis. ²⁶

- 6. LOUISSON³ LAFFERTY (PIERRE², JOSEPH¹) was born in 1822 at Fort Resolution. In 1848, he married a Métis, MARIE LESPERANCE in Winnipeg, likely during a visit to his dad's (PIERRE²) farm. MARIE was the daughter of ALEXIS LESPERANCE (and MARGUERITE GUERNON), who worked with LOUISSON's dad (PIERRE) in the Athabasca district in 1821, and retired to a nearby farm in 1835 (lot 251).²⁷ MARIE's sister also married a Métis from the Athabasca district, JEAN BAPTISTE BOUCHÉ, who had employment connections with her dad (ALEXIS LESPERANCE) and in-laws (LOUISSON and PIERRE LAFFERTY).²⁸ The NSMA consider LOUISSON and MARIE to be among the founding parents of their society. LOUISSON and MARIE had 13 children, with the last eight born at Fort Rae. The children of LOUISSON and MARIE describe both parents as Métis.²⁹

She married a Métis, ALEXANDER WENTZEL, who worked with her dad from 1821 to 1832, including his posting to Great Slave Lake with her dad and uncle (PIERRE and LOUTS) in 1825. In 1835, ALEXANDER is reported to be farming lot 30 in St. Boniface, Red River settlement. When MARIE ANNE married the former co-worker of her dad and uncle, all three men were farming in the Red River settlement.

- 8. ALFRED LAFFERTY began work for the HBC in 1841. His ethnicity is given as "Nwest" in the HBC ledgers. In 1854, he was listed as a member of an arctic expedition (possibly with John Rae). ALFRED

later returned to the Red River where he was re-engaged by the HBC in 1857.37

9. MODESTE LAFFERTY⁴ (LOUISSON³, PIERRE², JOSEPH¹) was born 1850 in Vermillion, and died in 1891at Fort Good Hope. In 1870, he was listed in the HBC account book for Fort Resolution. MODESTE married a Métis, SOPHIE BEAULIEU.

- 10. HENRI (HARRY)⁴ LAFFERTY (LOUISSON³, PIERRE², JOSEPH¹) was born in 1854 at Fort Chipewyan. He married a Métis, CATHERINE BOUVIER, consolidating a long social relationship between two key ancestor groups. HENRI's dad (LOUISSON³) and granddad (PIERRE²), long interacted with CATHERINE's dad (BAPTISTE) and granddad (JOSEPH) in their NWC and HBC employment histories. ⁴² HENRI LAFFERTY worked as a steersman and middleman for the HBC at Fort Rae from 1868 to at least 1901, and probably longer (Fort Rae account books stop in 1901). Two of his children married into very old Great Slave Lake Métis families: FABIEN and MANDEVILLE. JOSEPH MANDEVILLE, for example, joined the NWC at Fort Chipewyan in 1798. ⁴³ HENRI's son HARRY "Legas" LAFFERTY became an important leader to the Fort Rae Métis community.
