**Hearing Order GH-3-2010
Publication Dates and Extension of Deadline for Application to Intervene, and to
provide comments on the List of Issues and Draft scope of Environmental
Assessment for persons notified via Windspeaker publication**

The Board has received correspondence from Westcoast Energy Inc., carrying on business as Spectra Energy Transmission ("Westcoast") dated 5 August 2010, regarding the dates of publication of the Notice of Public Hearing pursuant to section 34 (b) of the GH-3-2010 Hearing Order.

Publication in Chetwynd Echo, The Dawson Creek Mirror and The Dawson Creek Daily News on 13 August 2010; Le Franco and L'express du Pacifique on 16 August 2010; The Northern Horizon on 20 August 2010 and expected publication in Windspeaker September issue (mailing on 6 September 2010) are subsequent to the Board ordered publication date of 11 August 2010. However, Westcoast advises that these are the first available dates for these publications. Since these publication dates, with the exception of the Windspeaker, are prior to the 26 August 2010 deadlines for application of interventions and providing comments on the List of Issues and Draft Scope of Environmental Assessment (Appendices I and V of Hearing Order GH-3-2010), the Board accepts these dates.

The expected Windspeaker publication date is subsequent to the 26 August 2010 deadlines for intervention in the GH-3-2010 proceeding and providing comments on the List of Issues and Draft Scope. As a result, there may be interested persons who do not receive adequate notice of the proceeding, nor an opportunity to provide comments on the List of Issues or scope of the environmental assessment. Accordingly, the Board hereby amends the deadline for the filing of

applications to intervene and for providing comments on the List of Issues and Draft Scope of Environmental Assessment in the GH-3-2010 proceeding for those who may have become aware of the proceeding by Notice of Public Hearing published in Windspeaker. These persons have until noon (Calgary time) on 16 September 2010 to file applications to intervene and any comments.

Westcoast is directed to amend its Notice of Public Hearing for the Windspeaker to include this revised deadline for applications to intervene and to provide comments on the List of Issues and Draft Scope of Environmental Assessment.

Westcoast is directed to serve a copy of this letter on Aboriginal communities and organizations identified in Appendix 9-3 of the Westcoast Dawson Project application.
