Hearing Order GH-3-2010 regarding Westcoast Energy Inc., carrying on business as Spectra Energy Transmission (Westcoast) Dawson Project Draft Environmental Screening Report – Dawson Project

On 31 May 2010, Westcoast applied to the National Energy Board to construct and operate a natural gas processing plant and to construct, acquire and operate associated pipeline facilities (Dawson Project or the Project).

As part of its responsibilities under the *Canadian Environmental Assessment Act* (CEA Act), the Board initiated an environmental assessment for the Project. Pursuant to paragraph 31(b) of the GH-3-2010 Hearing Order, the Draft Environmental Screening Report (Draft ESR) is attached for public review and comment.
