**NOVA Gas Transmission Ltd. (NGTL)
2017 NGTL System Expansion Project (Project) Certificate GC-126
Sample Notices and Plan, Profile and Book of Reference**

The National Energy Board (Board) acknowledges receipt of NGTL's 2 November 2016 submission of its draft PPBoR, sample notices for service and publication, and its publication plan for the Project.

The draft PPBoR and sample notices submitted by NGTL satisfy the requirements of Section 50 of the *National Energy Board Rules of Practice and Procedure, 1995*. The Board is also of the view that, subject to revisions contained in Appendix I of this letter, they would satisfy the requirements of paragraphs 34(1)(a) and 34(1)(b) *National Energy Board Act*, and approves them subject to NGTL addressing those required revisions.

In its 2 November 2016 submission, NGTL proposed that the Book of Reference material for the three pipeline sections of the Project located entirely on Crown land include the start and end points only as reference for the route, on the basis that this would facilitate efficient publication of the section 34(1)(b) notices by minimizing the impact of a multi-page newspaper notice on the majority of smaller weekly publications for the Project. The Board accepts NGTL's proposal to use the Notice of Publication with the abbreviated line list, subject to the inclusion of the edits in the table found in Appendix I of this letter.

NGTL is reminded that any notice served and published under section 34 cannot depart in any material way from the notices as amended pursuant to Appendix I, and as approved by the Board.

Summary of Required Edits to PPBoR and
Notices [NEB Act Section 34(1)(a) and 34(1)(b)]

General Edits:

- Ensure certificate number GC-126 replaces GC-XXXX in the PPBoR and Notice for Service and Notice for Publication;
- Ensure correct start and end land descriptions for each of the pipeline sections are shown in the cover page of plan and profile drawings, Notice for Service and Notice for Publication;
- Correct the revision number of each of the plan and profile drawings so it matches the revision number of the corresponding book of reference;
- Ensure each track number is unique (for example: do not have more than one BL-0001 as found in Boundary Lake Section PPBoR);
- Ensure track numbers are consecutive in each plan and profile drawing and corresponding book of reference (for example: missing MR-008 from the McLeod River Section plan and profile drawing);
- Ensure track numbers in the book of reference match the track numbers found in the corresponding plan and profile drawing (for example: MR-1 vs. MR-001 in McLeod River section)
- Increase font size of the TPA, TFA, PNT, CTL and TFA boxes on the plan drawings so it clear and legible.
- Ensure that maps included with the Notices for Service are clear and easy to read, and are of a scale sufficient to identify, with reasonable accuracy, the location, dimensions and area of lands in relation to the remaining adjacent lands of the owner. An example of a map that is in an acceptable form is found in [A5G6Q1](#), PDF page 12 of 40.
- Add to each of the documents which contain the Board's Calgary, Alberta address, "Suite 210".
- Ensure that in the Notice of Publication, the addresses of the locations where the PPBoR will be available for public inspection are correct, provide street addresses and not P.O. Boxes, and include the phone numbers.

Insert a new paragraph, before the last paragraph on page 2 of 10 (A5G6Q1, PDF page 5 of 40) which reads...”A copy of the plan, profile and book of reference...” with the wording: “The Board’s Appropriate Dispute
