

**Attachment 6            Orders for temporary access**

Trans Mountain submitted 36 applications for orders authorizing temporary access to certain lands for survey work in advance of construction. A total of 8 applications were withdrawn, and the Board approved 28 applications by issuing 25 temporary access orders (in some cases multiple applications were addressed by a single order). No processes were underway at the time of the FCA decision.
