REGULATION OF TARIFFS

The tolls of Carrier are regulated by the National Energy Board on a complaints basis. Carrier is required to make copies of tariffs and supporting financial information readily available to interested Persons. Persons who cannot resolve traffic, tolls and tariff issues with Carrier may file a complaint with the NEB. In absence of a complaint, the NEB does not normally undertake a detailed examination of Carrier's tolls.

SPECIFIC RULES AND REGULATIONS

The following shall apply in addition to the rules in N.E.B. No. 40 and supplements thereto.

In Item 5, the following definitions are added:

"Storage Provider" means Plains Midstream Canada ULC, and any of its successors or permitted assigns.

ITEM 45 DEMURRAGE

Product will not be subject to demurrage charges; however, Product which is not removed on or before December 31, 2018 will be subject to regular demurrage charges set out in the Rules and Regulations for the Windsor Storage Facility.

ITEM 100 INCENTIVE RATE REQUIREMENTS

The Incentive Committed Capacity Long Term Flat Storage Rate set forth in this tariff is available to Shippers executing a Storage Services Agreement ("SSA") for a guaranteed volume of 232,000 Barrels per Month of Product into the Windsor Storage Facility until December 31, 2018.

Under this tariff, only Ethane-Propane Mix will be accepted from the Effective Date until December 31, 2018.

In the event that a Shipper fails to nominate and / or Tender 232,000 bbls (36,867 m3) of Ethane-Propane Mix, it shall nevertheless pay to the Carrier 232,000 multiplied by the per Barrel Incentive Committed Long Term Flat Storage Rate for each month, unless such shortfall is due to Carrier's inability to provide service or due to force majeure as set out in more detail in the SSA.
