



ORDER AO-001-GL-330

IN THE MATTER OF the *National Energy Board Act* (Act) and the regulations made thereunder;

AND IN THE MATTER OF an application dated 18 May 2017 by LNG Canada Development Inc. (LNG Canada or the Applicant) for an extension to the export commencement expiry date approved by Licence GL-330, filed with the National Energy Board (the Board) under File OF-EI-Gas-GL-L384-2015-01 01.

BEFORE the Board 12 February 2018

WHEREAS on 27 May 2016, following Order-in-Council P.C. 2016-404 (20 May 2016), the Board issued Licence GL-330 to LNG Canada authorizing the export of natural gas for a period of 40 years;

AND WHEREAS by way of letter application filed with the Board on 18 May 2017, LNG Canada applied to extend the export commencement expiry date specified in Condition 3 of Licence GL-330 from 31 December 2022 to 31 December 2027 and sought an amendment to reflect this change, if approved (Application);

AND WHEREAS the Board directed LNG Canada to serve a notice of the Application on Atlantic Pacific Spaceline Enterprise Incorporated (APSE);

AND WHEREAS on 1 August 2017, APSE filed a letter of comment with the Board;

AND WHEREAS on 14 August 2017, LNG Canada filed a reply to APSE's letter of comment with the Board;

AND WHEREAS the Board has examined the Application and supporting documents from LNG Canada and the letter of comment from APSE and has decided that it is in the public interest to grant the extension, recognizing that it does not alter the Board's view that the quantity of natural gas proposed to be exported under Licence GL-330 does not exceed the surplus remaining after due allowance has been made for the reasonably foreseeable requirements for use in Canada, having regard to the trends in the discovery of gas in Canada;

AND WHEREAS the Board is of the view that Licence GL-330 should be varied to reflect the requested extension;

AND WHEREAS the Governor in Council by Order in Council No. P.C. 2018-57 dated the 2 day of February, 2018, has approved the variation of Licence GL-330;

IT IS ORDERED THAT, pursuant to subsection 21(2) of the NEB Act, Condition 3 of Licence GL-330 is varied as follows:

3. This Licence shall expire on 31 December 2027, unless exports have commenced on or before that date, or the Board otherwise directs.

IT IS FURTHER ORDERED THAT all other terms and conditions contained in the original licence remain in force, and LNG Canada shall comply with them.
